#### **GROUNDS**

I, Glen Napthali, Delegate for the Director, Environment Protection Authority, being satisfied in accordance with section 44(1)(d) of the *Environmental Management and Pollution Control Act* 1994 (EMPCA) that in relation to the above-mentioned environmentally relevant activity that it is desirable to vary the conditions of a permit (see table below) hereby issue this environment protection notice to the above-mentioned person as the person responsible for the activity.

#### **PARTICULARS**

The particulars of the grounds upon which this notice is issued are:

- 1 Regulatory limits are varied to confirm that authorisation to treat sewage or wastewater on The Land has been removed.
- 2 Permit conditions need to be varied or removed or new conditions are needed to reflect that a Wastewater Treatment Works is no longer hosted on The Land.
- 3 A condition requiring notification of a change of ownership of The Land is needed because this Notice may affect title to land and the new owner's interests may be affected by pollutants emitted or disturbed by the activity.

### **DEFINITIONS**

Unless the contrary appears, words and expressions used in this Notice have the meaning given to them in Schedule 1 of this Notice and in the EMPCA. If there is any inconsistency between a definition in the EMPCA and a definition in this Notice, the EMPCA prevails to the extent of the inconsistency.

# REQUIREMENTS

The person responsible for the activity must comply with the varied permit conditions as set out in Schedule 2 of this Notice.

### **INFORMATION**

Attention is drawn to **Schedule 3**, which contains important additional information.

### **PENALTIES**

If a person bound by an environment protection notice contravenes a requirement of the notice, that person is guilty of an offence and is liable on summary conviction to a penalty not exceeding 1000 penalty units in the case of a body corporate or 500 penalty units in any other case (at the time of issuance of this Notice one penalty unit is equal to \$168.00).

### NOTICE TAKES EFFECT

This notice takes effect on the date on which it is served upon you.

#### APPEAL RIGHTS

You may appeal to the Appeal Tribunal against this notice, or against any requirement contained in the notice, within 14 days from the date on which the notice is served, by writing to:

### **Schedule 1: Definitions**

**Activity** means any environmentally relevant activity (as defined in Section 3 of EMPCA) to which this document relates, and includes more than one such activity.

**Director** means the Director, Environment Protection Authority holding office under Section 18 of EMPCA and includes a person authorised in writing by the Director to exercise a power or function on the Director's behalf.

EMPCA means the Environmental Management and Pollution Control Act 1994.

**Person Responsible** is any person who is or was responsible for the environmentally relevant activity to which this document relates and includes the officers, employees, contractors, joint venture partners and agents of that person, and includes a body corporate.

The Land means the land to which this document relates and includes: buildings and other structures permanently fixed to the land, any part of the land covered with water, and any water covering the land. The Land is defined by certificate of title volume 157583 folio 1.

Wastewater Treatment Works means the conduct of wastewater treatment works that involve the discharge of treated or untreated sewage, septic tank effluent or industrial or commercial wastewater to land or water, being works with a design capacity to treat an average dry weather flow of 100 kilolitres or more per day of sewage or wastewater.

### **Maximum Quantities**

# Q1 Regulatory limits

- 1 The activity must not exceed the following limits (annual fees are derived from these figures):
  - **1.1** 0 kilolitres per day capacity to treat an average dry weather flow of sewage or wastewater.

### General

# G1 Activity restriction

Unless otherwise approved, a Wastewater Treatment Works must not be hosted on the Land.

# G2 Change of ownership

If the owner of The Land upon which the activity is carried out changes or is to change, then, as soon as reasonably practicable but no later than 30 days after becoming aware of the change or intended change in the ownership of The Land, the person responsible must notify the Director in writing of the change or intended change of ownership.
